

Terms and Agreement

1. Little Tots International Family Daycare (hereafter referred to as LTI) is a privately-owned family daycare established in 2016, which expanded into a daycare in 2018.
2. LTI provides full-time, part-time and short-term childcare to families in the Helsinki region. LTI also offers babysitting services within Helsinki, Espoo and Vantaa regions.
3. Babysitting is available daily from 8am until 10pm. Babysitting may be done at the home of the family or in an agreed location.
4. Babysitting mainly focuses on the care for your child. Doing some light household chores can be discussed with the babysitter, as long as there is only one (1) child being looked after.
5. The family is requested to give at least two (2) days' notice when applying for babysitting.
6. The minimum hour for babysitting is two (2) hours/ day.
7. The invoice is sent via email and has to be paid on the due date specified in the invoice.
8. In case the invoice is not paid within two (2) from the due date, another invoice will be reissued with a 5€ reminder fee as well as the valid interest of 8%.
9. In case of cancellation, the family must call LTI by 7pm the day before the agreed babysitting. Otherwise, 50% of the payment will be charged. In case of the babysitter's absence, LTI will try to find a substitute and inform the family at least four (4) hours before the agreed babysitting whether or not a babysitter is able to come.
10. In case of overtime, please inform LTI as soon as possible. Overtime of ten (10) minutes past the agreed time is charged for an additional hour.
11. In case of accidents, the babysitter will report the situation to the child's parent/ guardian and the child's parent/ guardian will bring the child to the nearest health care center or to Lastenklินิกка, when necessary. The child/ren are insured by LähiTapiola during the babysitting hours with LTI.
12. LTI requests the family to give their feedback on our babysitting service and the babysitter by writing a review on our Facebook page, www.facebook.com/littletotsintl.
13. LTI reserves the right to amend any of the terms and agreement stated in this contract.
